Adopt the 2016-2017 Primary Property Tax Levy and Mall Maintenance District Property Tax Levy

SUMMARY RECOMMENDATION:

Adopt the 2016-2017 Primary Property Tax Levy and Mall Maintenance District Property Tax Levy.

REPORT:

The City of Yuma 2016-2017 Final Budget is based in part upon an estimated primary property tax levy that is anticipated to raise \$12,144,078 in tax revenue. This estimate is derived from the assessed valuation as of February 10, 2016, provided by the Yuma County Assessor (date stipulated by state law), and multiplied by a tax rate of \$2.3517 on each \$100.00 of assessed valuation. This tax rate is an increase from the 2016 rate of \$2.0704 on each \$100.00 of assessed valuation.

There has been no secondary property tax levy since 1992.

The tax rate for the Mall Maintenance District is increasing to \$4.7820. The rate of \$4.7820 on each \$100.00 of assessed valuation is anticipated to raise approximately \$105,000 in tax revenues.
