TITLE: Agreement Amendment: Yuma County Intergovernmental Public Transportation Authority					

SUMMARY RECOMMENDATION:

Authorize the City Administrator or his designee to execute an intergovernmental agreement (IGA) amendment between the City of Yuma (City) and the Yuma County Intergovernmental Public Transportation Authority (YCIPTA) for Federal Transit Administration (FTA) pass through funds to help support the development of a multimodal transportation center at the historic Hotel Del Sol.

REPORT:

Over the past decade, the City of Yuma (City) and YCIPTA have been working together to complete an adaptive reuse of the historic Hotel Del Sol into the community's first multimodal transportation center. Thus far, more than \$900,000.00 in federal and local funding has been expended on environmental work, design, acquisition, minor abatements, securing the facility, and a project implementation and design plan.

On February 26, 2015, Yuma City Council approved an intergovernmental agreement between the City and YCIPTA to which YCIPTA passed funds from Grant Number AZ-90-X132 and AZ-90-X127 to the City to help with funding the improvement and rehabilitation of the Hotel Del Sol into a multimodal transportation center. The term of the IGA expired August 26, 2017 but approximately \$965,000.00 in grant funds remain. Several grant opportunities are currently being pursued for the construction phase of this project and therefore, YCIPTA and the City desire to extend the term of the IGA for one year to allow the City to use these grant funds to help support the rehabilitation of the Hotel Del Sol upon receipt of additional grant funding.
