## REPORT:

Richard Good, agent for Jimmie Dees located at 38 W. 2<sup>nd</sup> Street, has applied for a Temporary Extension of Premises/Patio Permit of the noted businesses current liquor license. The requested extension is to include a portion of the business' parking lot area to accommodate additional patrons while allowing for social distancing.

Through a new City process to aid businesses during the COVID pandemic, an Extension of Premises agreement, approved through Community Development, allows businesses to operate in City rights-ofway and other property not typically used for business. This agreement was put in place to encourage outdoor activity, allows additional area for social distancing and assists with keeping businesses operating. The temporary extension will expire 6 months from the date of issuance from AZDLLC or the Governor's withdrawal of Emergency Order No. 2020-60, whichever is later.

The application has been sent to Community Development, the Police Department, the Fire Department, and Business Licensing for review. No objections have been received.

Upon City Council's recommendation of approval, the application will be forwarded to the Arizona Department of Liquor Licenses and Control for final processing.

Approval of this Motion Consent item would align with City Council's Respected and Responsible Strategic Outcome as it provides notification to the public and transparency of City business.
