Bid Award: Terraces At The View Storm Drain

**SUMMARY RECOMMENDATION:**

Award to the lowest responsible and responsive bidder for the construction of the Terraces at the View Storm Drain in the amount of \$164,576.00 to:

Mountain High Excavating, LLC    Flagstaff, Arizona

(Public Works - Bid #2017-20000153) (Joshua Scott)

**REPORT:**

The Arizona Department of Transportation (ADOT) Improvements to the Araby Road and Interstate 8 traffic interchange will increase the discharge flows of the Terraces at the View storm drain. ADOT conducted a study and concluded that the existing 18" diameter pipe should be enlarged to 36" to increase the discharge flow capacity and that an energy dissipator should be added to decrease the discharge velocity.

The project will include replacement of existing 18" diameter concrete storm drain with 36" and 18" diameter rubber gasketed reinforced concrete pipe storm drain between Overlook Lane and Terraces at the View subdivision retention basin; removal and replacement of the existing storm drain manhole and outlet headwall; and, miscellaneous concrete and masonry work.
