CALL TO ORDER

Mayor Nicholls called the City Council meeting to order at 5:31 p.m.

INVOCATION/PLEDGE

Father Timothy True, St. Paul's Episcopal Church, gave the invocation. James Hamersley, Chief Information Officer, led the City Council in the Pledge of Allegiance.

FINAL CALL

Mayor Nicholls made a final call for the submission of Speaker Request Forms from members of the audience.

PRESENTATIONS

Chief Irr gave recognition certificates to the following citizens who assisted the Yuma Fire Department (YFD) during two separate incidents:

- June 17th A semi-truck rollover occurred on Interstate 8 at 16th Street, where the driver was trapped inside the cab underneath the vehicle. **Irr** stated a hoist was needed to get to the driver and Jack Jones, an operator at Dick's Towing, jumped in to give the needed assistance. Dick's Towing, and the late Dick Rautenberg, have been big supporters of public safety and the fire department for many years and Jack Jones, who worked with Dick Rautenberg, is carrying on that tradition.
- May 7th Carson Fricke was participating as a member of the U.S. Navy Seal Cadets doing some physical training when he collapsed at Castle Dome Middle School. Two leaders, Edward Sheffield and Justin Moseley, assessed Fricke and realized that he was in cardiac arrest. They immediately called 911 and began CPR until the YFD crew arrived. **Irr** noted that according to the American Heart Associations 'chain of survival' relating to potential cardiac arrest, Sheffield and Moseley did exactly what they should have done. **Irr** stated that as a result of this incident, Castle Dome Middle School brought in CPR Trainers and the entire school received CPR training.

III. ADOPTION OF ORDINANCES CONSENT AGENDA

Mayor Nicholls pulled Ordinance O2016-022 for separate discussion.

<u>O2016-022 City of Yuma 2016 Special Election</u> – Call a special election to be held the same time as the City of Yuma General Election on November 8, 2016 to submit to those persons qualified to vote in the City of Yuma the question of increasing the Transaction Privilege Tax levy by three-tenths of one percent (0.3%). (Administration)

Motion (Craft/Knight): I move that Ordinance O2016-022 be amended as follows:

- 1) That 'fiscal year 2019' be replaced with 'fiscal year 2020' in the 5th whereas clause; and,
- 2) That the language "at the same time as the City of Yuma General Election" be stricken from Section 1; and,
- 3) That a Clerk's Note be placed on the staff report to reflect these changes, and
- 4) I further move to reintroduce Ordinance O2016-022, as amended.

Voice vote: **approved** 7-0.

Speakers:

Wayne Benesch, 230 W. Morrison Street, Yuma, stated he was pleased with the proposed form of ordinance and ballot measure as it addressed some of the points, regarding the proposed sales tax increase, that were brought up in a letter to Mayor and Council by a citizens group. Those items included adopting a moratorium on real property tax increases for a minimum of three years and limiting the use of any proceeds from the increase of the sales tax to public safety salaries and benefits or for road and street repairs or improvements. **Benesch** continued stating there were two additional items that were raised for consideration that he would like City Council to consider: 1) the formation of a transparent citizens committee that would report directly to City Council. The committee would thoroughly study the budget process, explore any weaknesses and suggest improvements; and, 2) to engage a qualified consultant to perform an efficiency study of the City's entire operations in order to determine where cost savings may be achieved.

Mayor Nicholls responded that the letter did contribute to the conversations over the last couple of weeks and he thanked Mr. Benesch.
