TITLE:

Ratify and Accept Grant Award: Edward Byrne Memorial Justice Assistance Grant (JAG) Program

SUMMARY RECOMMENDATION:

Authorize the City Administrator to execute the required Memorandum of Understanding (MOU) documents for the Edward Byrne Memorial Justice Assistance Grant Program awards to ratify the acceptance of: Fiscal Year 2018 award in the amount of \$47,883; Fiscal Year 2019 award in the amount of \$43,325; and, Fiscal Year 2019 award in the amount of \$199,975; as well as accept the Fiscal Year 2020 award in the amount of \$31,218. (Police/Patrol) (Susan Smith)

REPORT:

The Justice Assistance Grant (JAG) Program is the primary provider of federal criminal justice funding to state and local jurisdictions. The City of Yuma, through the Yuma Police Department, was awarded funding to support the working relationship with other local law enforcement agencies. The JAG grant funding from the U.S. Department of Justice is utilized to maintain interoperability data sharing communication between public safety agencies in Yuma County, for accessing and sharing information at federal, state and local levels.

YPD and local law enforcement partners have received JAG funding for many years. During this current year's application process, it was learned that individualized MOUs between the participating agencies were necessary for each grant. The City and County executed the MOU for the current Fiscal Year (FY) 2020 application and award. The JAG program also requested that the City and County also ratify the past relationship and awards through post-dated formal MOUs for the FY 2018 and the two FY 2019 applications and awards.

The City seeks City Council authorization to execute the required MOU documents between the City and County for the federal JAG awards (CFDA #16.738):
