**SUMMARY RECOMMENDATION:**

Approve a Temporary Extension of Premises/Patio Permit application submitted by Richard Good, agent for Ricky's Other Place located at 3950 W. 24th Street, for a scheduled event on March 25<sup>th</sup> and 26<sup>th</sup>, 2017. (EP17-01) (City Administration/City Clerk) (Lynda L. Bushong)

**REPORT:**

Richard Good, agent for Ricky's Other Place located at 3950 W. 24<sup>th</sup> Street, has applied for a Temporary Extension of Premises/Patio Permit. The requested extension is to include a portion of the business' parking lot for the purpose of an outdoor concert and food court that is scheduled to begin at 2:00 p.m. on March 25<sup>th</sup> and continue until approximately closing time [2:00 a.m.], which would include the 26<sup>th</sup>. The extended area will be fenced and a minimum of 10 additional security officers will be on site.

The application has been sent to Community Development, the Police Department, the Fire Department, and Business Licensing for review. No objections have been received.

Upon City Council recommendation of approval, the applicant will forward the application to the Arizona Department of Liquor Licenses and Control for final processing.
