TITLE:

Agreement: Yuma Regional Medical Center Base Hospital Agreement

SUMMARY RECOMMENDATION:

Authorize and direct the City Administrator to execute a Base Hospital Agreement with Yuma Regional Medical Center. (Fire/Administration) (Steve Irr)

REPORT:

Under Arizona Revised Statutes § 36-2201, *et seq* and Title 9 of the Arizona Administrative Code, any agency that provides emergency medical services must enter into an agreement with a hospital to provide on-line medical supervision, medical direction, and prehospital coordination. The City of Yuma (City) has had an agreement with Yuma Regional Medical Center (YRMC) to serve in that capacity since the City began providing advanced life support services in the 1970s. The proposed agreement (Agreement) satisfies the statutory and regulatory requirements for the City to continue providing advanced life support services.

Under the Agreement, YRMC will provide administrative and on-line medical direction, a medical director, and a prehospital coordination for the City at no cost. Administrative medical direction covers items such as chart reviews and signing recertification applications. On-line medical direction means that a doctor is available via radio/phone 24/7, to provide treatment orders to paramedics in the field. YRMC will also assist the City with quality control of medical records.

The Agreement has an initial term of five years, with the option to renew for up to two successive five-year terms for an aggregate term of 15 years. Both the City and YRMC may terminate the Agreement at any time, for any reason by providing 30 days written notice.

By approving this motion, the City Council authorizes and directs the City Administrator to execute the appropriate agreement documents.
