Cooperative Purchase Agreement: Pierce Arrow Pumper

SUMMARY RECOMMENDATION:

Authorize the purchase of one Pierce Arrow XT PUC Pumper (fire truck) utilizing the cooperative purchase agreement originated by the Houston-Galveston Area Council at a total cost of \$726,910.18 to:

Pierce Manufacturing, Inc. Appleton, Wisconsin

(Fire Department - Bid #2018-20000155) (Steve Irr - Robin R. Wilson)

REPORT:

This fire truck purchase is a replacement for a 1998 Pierce Quantum/Tele-Squirt with over 200,000 miles. This pumping apparatus will be designed to safely seat up to six firefighters, carry water and needed equipment to combat major fires, emergency medical response, hazardous material responses, technical rescue and automobile extrication responses.

Funds are included in the Equipment Replacement Fund for the replacement of one unit. Pierce Manufacturing is offering a pre-payment discount of \$38,359.86.
