CALL TO ORDER

Mayor Nicholls called the City Council meeting to order at 5:30 p.m.

Mayor Nicholls made a final call for the submission of Speaker Request Forms from members of the audience for agenda related items.

PRESENTATIONS

Arizona Complete Health Grant Award

Lee-James thanked Arizona Complete Health (Cenpatico) and their Vice President, Greg Taylor for being one of Yuma's strongest community partners and by joining in on the efforts to ensure residents of the community have homes that are free of hazards and safety issues.

Greg Taylor thanked the City of Yuma for allowing them to meet the needs of those individuals by keeping their homes in the conditions they need to be. He informed City Council that between the investments made this year and another that will be made next year, Arizona Complete Health is contributing \$25,000 towards this program to make sure it is successful for those that live in the Yuma community.

Pacific Avenue Athletic Complex (PAAC) Update

Wendt and Chavez presented the following information related to the Pacific Avenue Athletic Complex (PAAC):

- Before the opening of the PAAC
 - ✓ Averaged 16 tournaments per year, which included City and private hosted tournaments
 - Revenues collected from City Leagues and Tournaments in FY 2016-2017 were \$93,038.00
 - ✓ Rental revenues from private tournaments in FY 2016-2017 were \$8,328.00
- PAAC from September 2017 to September 2018
 - ✓ 28 tournaments hosted
 - \checkmark 675 total teams with 275 out of town teams
 - ✓ 136,269 players, spectators & visitors
 - \checkmark Out of 365 days of the year, the PAAC was used 270 days
 - ✓ Youth Leagues share the PAAC during their seasons 2-3 days a week
- New Customers Private Tournaments and Events from 2017-2018
 - ✓ Southwest Premier Tournaments, USBP Toys for Tots, AWC Women's' Fast-pitch, E-1 Sports, 2 Local Teams (Hosted their own tournament), Cal Ripken State Tournament
- New City Tournaments/Leagues included:
 - ✓ Cinco De Mayo Softball Tournament, Additional Co-Rec Softball League, 2 Kickball Tournaments, Kickball League
- Revenues from September 2017 to September 2018
 - ✓ Revenues collected from City only Leagues and Tournaments: \$112,308.00
 - ✓ Rental revenues collected from private tournaments: \$26,031.00
 - ✓ Gate fees collected for all tournaments: \$118,124.00
 - \$88,104.00 went back to the promotor
 - o City's share: \$30,020.00
 - ✓ Concession sales totaled \$249,466.00
- Revenue/Expenditure Overview:
 - ✓ Total revenues collected since the PAAC opened: \$447,190.00
 - Revenues collected for City of Yuma Adult Leagues in fiscal year (FY) 2016-2017: \$93,098.00
 - ✓ Revenues collected for Private tournaments in FY 2016-2017: \$8,382.00
 - ✓ Total Labor Costs for Full-time and Part-time employees to include recreation, concessions and maintenance at the PAAC: \$302,516.00
 - ✓ Estimated Economic Impact: \$1,380,000.00

- Two Percent & Sales Tax:
 - ✓ August 2018 saw an 8.4% increase over last year, improving on the July increase year-toyear of 6.2%, which in turn pushed the fiscal year to date increase to 7.3%.
 - ✓ The two percent and sales tax increase totaled \$18,000 or 4.7% more than last August with an increase of 3.1% fiscal year to date (YTD) and an increase of 6.3% calendar YTD
- Field Usage Requests
 - ✓ Inventory of 8 Softball Facilities: 20 Softball Fields (Including the PAAC) provides:
 - Practice Reservation
 - Scheduled Games
 - Private Rental Opportunities
 - City of Yuma Tournaments

Wendt and **Chavez** concluded the presentation by informing City Council that the success of the PAAC will continue. Discussions with several new tournament vendors have been conducted and reservations for new tournaments have been made. The Parks and Recreation Department continues to work with other local organizations to promote potential tournament opportunities within the Community.

Discussion:

Shelton asked several questions all of which were marketing oriented. He questioned what Parks and Recreation have been doing to market the PAAC locally with tournaments. **Wendt** informed City Council that although they do not have the funds to publicize upcoming tournaments on television or at the Yuma Sun it is however available on the City of Yuma website [www.yumaaz.gov], the Parks and Recreations Activity Guide, along with being broadcasted on the radio every Thursday. **Shelton** expressed his concern in having certain people in the community still not aware of the local activities occurring at the PAAC. He suggested having a local business owner donate and promote a marque that stands out front of the PAAC so all the Yuma community can see the schedule of upcoming events.

Watts asked if the PAAC is being used during the summer months, especially in July and August. Chavez advised during the summer months they host late night tournaments starting around 8:00 p.m. that go till early in the morning.

Knight explained that the money paying for the PAAC and the bond payments on the PAAC is 2% funding, which is restricted and cannot be used for roads or public safety. He asked if there are any general funds to pay down the debt on the PAAC. **Wilkinson** stated there were not. **Knight** noted that the PAAC is doing as City Council intended. He asked if there will be more reservations next year or if it is anticipated to be the same. **Chavez** answered that things are looking close to what they were last year but Parks and Recreation is continuing to work with vendors and outside people who want to come into Yuma for tournaments.

Thomas asked what the annual bond payment is for the PAAC. Wendt estimated the bond payment is just over one million dollars a year.

Mayor Nicholls questioned the current timeframe on naming rights for the PAAC. He stated "PAAC" does not necessarily provide an identity of the complex and suggested marketing to have someone pay to name the complex. Wendt agreed.

Resolution R2018-036– General Plan Amendment: Barkley Limited Partnership – Approve the request to amend the City of Yuma General Plan to change the land use designation from Suburban Density Residential to Low Density Residential, for property located at the northwest corner of the Avenue B ¹/₂ alignment and 40th Street. The applicant is Barkley Limited Partnership (GP-22312-2018)

Mayor Nicholls opened the public hearing at 6:50 p.m.

Albers recapped that this request is to amend the General Plan changing the land use designation from Suburban Density Residential to Low Density Residential. She explained the property that is currently under farm agriculture use is located at the northwest corner of the Avenue B ¹/₂ alignment and 40th Street. The applicant intends to develop a single-family home subdivision similar to the Livingston Ranch subdivision to the north with the R-1-6 Low Density Residential zoning district. She informed

City Council that the request was approved by the Planning and Zoning Commission at their September 24, 2018 meeting.
