**SUMMARY RECOMMENDATION:**

Declare the results of the August 29, 2017 City of Yuma Primary Election through the official canvass.

**REPORT:**

The City of Yuma Primary Election was held on Tuesday, August 29, 2017, for the purpose of nominating candidates for the offices of:

- Mayor (one seat),
- City Councilmembers (three seats) and,
- Presiding Municipal Judge (one seat)

The results of the election are contained in the official canvass to be adopted by this resolution.

As required by the Yuma City Charter and Arizona Revised Statutes (ARS) §16-642, the City Council shall declare by resolution the results of the Primary Election not less than six days nor more than 20 days following the election. ARS § 16-646 requires the official canvass to contain certain information, which has been included in the resolution.
