Mayor Nicholls called the City Council meeting to order at 5:31 p.m.

An ordinance of the City Council of the City of Yuma, Arizona, amending Title 5 of the Yuma City Code, Chapter 50, by amending Section 6, pertaining to the Functions of the Parks, Arts, and Recreation Commission (broaden the functions of the Parks, Arts, and Recreation Commission to include the importance of maintenance and protection of City owned trees and other woody plants, and to further define the Commission's role as it relates to public art advocacy)

Shelton, Miller, Knight and **Mayor Nicholls** reported on events and meetings they have attended during the last two weeks and upcoming events of note.

Scheduling:

Watts stated she looks forward to the Pay Plan discussion that addresses the concerns of the Yuma Police Department (YPD) and to curb the crisis and retention issues. She mentioned that waiting for a crisis to occur is not a sustainable plan, and City Council needs to be diligent in the preparedness for the future of the City of Yuma. She requested placing a Pay Plan discussion for YPD on the November 7th, 2018 regular City Council Meeting.

Motion: (Watts/McClendon): To place discussion and possible action of the Pay Plan for Yuma Police Department on the November 7th, 2018 Regular Council Meeting. Voice vote: **approved** 7-0.

IX. CALL TO THE PUBLIC

Norma Nelson, 1734 Camino Cerro, stated she would like to see the City look into adopting the same model Yuma School District One uses when Military families relocate to Yuma; mentioning if the children in the family are engaged in any activity when they come to the District they will automatically resume that same activity.

Charles R. Lenz, 13639 S. Onammi Avenue, expressed his concerns of the City being inadequately patrolled and further requested that differential-shift pay should be considered.

John Courtis, 2522 S. Elmwood Drive, stated that the budgeted balance carry over funds should be used to help alleviate some of the police department issues. He believes that addressing the Yuma Police Departments concerns and moving forward with the pay plan is essential. He understands supporting the entire City team; however agrees with the urgency in correcting the public safety compensation issues first.

Eric Egan, 13393 E. 43rd Lane, President of the Fraternal Order of Police, thanked City Council for taking the time in discussing the pay issues. He spoke on the urgency of getting this concern taken care of due to many other agencies, such as DPS, hiring for the Yuma area. He concluded by mentioning his team members are wanting to stay with the City of Yuma and have faith in City Council to make the right decisions during this difficult time.

Ken Rosevear, 4655 W. Sundown Drive, stated the presentations made by Chief Lekan and Chief Irr were excellent. They provided the numbers and solutions needed to fix the problems with the public safety pay issues. He recommended City Council act on this issue and not let it linger any further.
