## SUMMARY RECOMMENDATION:

Approve the corrected final plat for the Pro-Med Subdivision. The property is located at the northwest corner of 24th Street and Ridgeview Drive, Yuma, Arizona. The applicant is Pro-Med of Yuma, LLC. (SUBD-16086-2016) (Community Development/Community Planning) (Laurie Lineberry)

## **REPORT:**

At the February 1, 2017 regular City Council meeting, the City Council approved MC 2017-019, the final plat for the Pro-Med Subdivision. That final plat map included the existing Pro-Med building, as well as the new vacant parcels that will be developed in the future. The actual Pro-Med building was platted and developed more than 10 years ago and has now been sold to an out-of-state real estate investment firm. Pursuant to the guidelines in Title 9 and Title 32 of the Arizona Revised Statutes, the recordable final plat needs to be corrected to show the new, vacant subdivision parcels without the existing Pro-Med building so it may be accepted by the Yuma County Assessor. The corrected final plat for the Pro-Med Subdivision is attached as Exhibit A.

Approving this motion will correct the subdivision final plat for recording and acceptance by the Yuma County Assessor. The corrected final plat will be subject to the same conditions of approval set forth in the February 1, 2017 City Council approval, but will not include the existing Pro-Med building.
