Summary Recommendation: Authorize the sale of approximately 758 square feet of City-owned property generally located at 1916 S. Ridgeview Drive. (Engineering) (Jeff Kramer)					
REPORT: During a construction project in mid-2015, City staff realized that the north side of a lot located at 1916 South Ridgeview Drive encroached onto City property used for a retention basin by approximately 758 square feet. The City issued a certificate of occupancy for the home at this location in 1979. A location map with the property lines displayed over an aerial photograph is attached for reference. From the location map, it appears that at the time of design and construction, the original builder assumed a straight-line property boundary between the northwest property corner and the northeast property corner of the 1916 S. Ridgeview Drive property. A no-fee encroachment permit is currently in effect for the property. The attached proposed ordinance declares the described 758 square feet of property surplus for City use and authorizes a sale of the property to the adjacent landowners. The proposed sale will not affect the capacity of the City's retention basin.
