WHEREAS, the City has identified the need to acquire a portion of the real property and certain easements in the real property owned by PMG Partnership, LLC; and,

WHEREAS, the described property will serve a necessary and public use and be of public benefit in the redevelopment of the north east corner of 16th Street and 4th Avenue.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Yuma as follows:

<u>SECTION 1</u>: It is deemed necessary and essential, as a matter of public necessity and public welfare, that a portion of the real property described in Exhibit A and by this reference made a part of this Ordinance, be acquired by the City of Yuma, together with certain easements for the purpose of access and circulation.
