Summary Recommendation: Adopt the 2018-2019 Primary Property Tax Levy and Mall Maintenance District Property Tax Levy (Finance/Administration) (Pat Wicks)					
REPORT: The City of Yuma 2018-2019 Final Budget is based in part upon an estimated primary property tax levy that is anticipated to raise \$12,593,215 in tax revenue. This estimate is derived from the assessed valuation as of February 10, 2018, provided by the Yuma County Assessor (date stipulated by state law), and multiplied by a tax rate of \$2.2747 on each \$100.00 of assessed valuation. This tax rate is a decrease from the 2017-2018 rate of \$2.3001.					
There has been no secondary property tax levy since 1992. The tax rate for the Mall Maintenance District is \$4.6718 on each \$100.00 of assessed valuation, which is higher than the 2017-2018 tax rate of \$4.4889. The levy is anticipated to raise approximately \$106,825 in tax revenues, slightly higher than the levy of \$105,000 for Fiscal Year 2017-18.
