CALL TO ORDER

Mayor Nicholls called the City Council meeting to order at 5:30 p.m.

INVOCATION/PLEDGE

Pastor Phillip Hayman, Valley Baptist Church, gave the invocation. **Monica Welch**, Human Resources Director, led the City Council in the Pledge of Allegiance.

Mayor Nicholls made a final call for the submission of Speaker Request Forms for agenda related items from members of the audience.

PRESENTATIONS

Proposed Art Center MOMO Mural

Wendt introduced Lindsay Benacka, Arts & Culture Program Manager, and Maria McKivergan, member of the Ad-Hoc Public Art Committee, who will personally sponsor the project along with her husband Michael.

Benacka stated that MOMO is a contemporary conceptual artist who specializes in large-scale works of public art. He is interested in using practical geometry and engineering to create his work. She explained that MOMO will spend the entire month of February 2018 in Yuma installing the mural on the back wall of the Yuma Art Center and getting to know the community, participating in educational opportunities in area classrooms with Yuma's youth, and partnering with local artists to help him complete the project. The ultimate goal is to create a contemporary statement work of art to encapsulate the personality of the Yuma Art Center and the architecture of the space. She noted that this project was unanimously approved by the Parks, Arts, and Recreation Commission as well as the Design and Historic Review Commission. Both groups are very excited about the project because of the rejuvenation it will bring to the downtown district.

McKivergan thanked the City for supporting her and her husband's creative ideas. As art lovers and collectors, they hope to bring a little more art to Yuma. In terms of art tourism, their goal is to make Yuma 'cool' and enjoyable for people of all generations.

Thomas asked if MOMO is an acronym or if it is actually the artist's name. **McKivergan** stated that it is a shortened version of his last name. **Thomas** noted that Benacka mentioned when MOMO is in Yuma he will be partnering with local artists and asked if he does that when he goes to other cities. **McKivergan** stated that he uses both artists that travel with him and local artists to assist him. **Thomas** asked what the proposed rendering is supposed to be. **McKivergan** stated that as abstract art it is anything the viewer wants it to be.

Shelton urged City staff to reach out to local elementary, junior high, and high schools to participate in the educational opportunities during MOMO's stay.
