REPORT: The Arizona Department of Transportation (ADOT) is improving the Araby Road and Interstate 8 traffic interchange starting June 1, 2017. The City is required to relocate a waterline that is in conflict with ADOT improvements.						

The project consists of replacement of an existing 16" diameter asbestos cement (AC) pipe with 16" diameter PVC and ductile iron pipe on Araby Road between the Union Pacific Rail Road and 26th Street within ADOT right-of-way limits. The project also includes the replacement of an existing 10" diameter AC water service line with 10" diameter PVC pipe off of Gila Ridge Road to the southwest corner (Tanimura and Antle property), and miscellaneous removal of existing AC water lines, curb, sidewalk, and asphalt.
