TITLE: Vehicle Allowance Modification					
Summary Recommendation:  Modify existing terms of employment related to vehicle allowance for City Administrator and Deputy City Administrator.					
REPORT:  Modify existing terms of employment related to a monthly vehicle allowance to City Administrator and Deputy City Administrator in the equal amounts of \$600 per month, each. Specifying an allowance rather than a City furnished vehicle shifts all responsibility and risk from the City onto the vehicle owner. This is especially important for out-of-state travel in that thirty-six other states including California, Nevada, Colorado and New Mexico have either strict or modified joint and several liability, meaning, in the event of an accident, the deepest pocket pays then has to file a subrogation lawsuit against any other tortfeasor.					
With a vehicle allowance, the vehicle owner pays all costs associated with the vehicle, including all operating expense, insurance, licensing, taxes, maintenance, and repairs. Making these changes will result in a cost savings to the City and reduce the City's potential liability.
