SUMMARY RECOMMENDATION:

REPORT:

The City has been utilizing open-ended consultant contracts for various types of engineering services on a delivery order basis since 1995. These on-call contracts were used to obtain study and design services; bid assistance; construction inspection and administration and post-construction documentation and analysis; land survey; and other related professional services as necessary by the City for Capital Improvement Program (CIP) and other miscellaneous projects required by individual City departments.

An RFQ process was initiated to obtain statement of qualifications (SOQ) submittals from qualified engineering firms to perform the services under a delivery order form of contract in accordance with, and as regulated by, current State of Arizona Board of Technical Registration Code and Rules. Each project will be authorized by a delivery order specifying the scope of services required, the maximum time allowed for the services and the fee. Although the amounts will vary, the maximum value of each contract shall not exceed \$500,000.00 for a 12-month period. The City will not guarantee each delivery order will be any specific amount or that the Consultant(s) will receive a minimum number of delivery orders.

The City received SOQs from 25 firms. The evaluation committee, comprised of City staff, reviewed and rated the proposals received, based on the scoring matrix provided to each firm within the RFQ. The firms listed above consist of the ten highest-ranked firms as determined by the evaluation committee scoring. Based on the CIP potential workload projected within the next five years, staff recommends to award to the top 10 firms as those firms listed provided all the disciplines required.

However, the following eight firms are qualified and are recommended for potential awards if the City so chooses:
