SUMMARY RECOMMENDATION: Authorize the City Administrator to sign a Memorandum of Understanding with the Naval Criminal Investigative Service (NCIS) to share and access law enforcement information and records with NCIS and other partnering agencies via SoCal LInx.						
REPORT: The Southern California Law Enforcement Information Exchange (SoCal LInX) is a federally sponsored information sharing initiative for the operation of a regional warehouse of databases. SoCal LInX was established to combat crime and terrorism by identifying and locating criminals, terrorists, and their supporters; identifying, assessing and responding to crime and terrorist risks and threats; and preventing, detecting, and prosecuting criminal and terrorist activities. SoCal LInX achieves this by providing a platform for federal, state, county and municipal law enforcement agencies to share pertinent information and thereby providing each agency with a single source for regional law						

The City of Yuma (City), through the Yuma Police Department (YPD), wishes to partner with NCIS in order to access SoCal LInX. Under this memorandum of understanding (MOU), YPD would be added to the SoCal LInX allowing YPD access to the records and information of the federal, military, state, county, and municipal law enforcement agencies currently accessing SoCal LInX. In turn, under the MOU YPD agrees to share its records.

enforcement information.

Among other things, joining SoCal LInX allows YPD to (i) reduce the time it spends searching for and retrieving relevant data; (ii) develop analytical products to support violent crime and counterterrorism operational and investigative activities; and (iii) provide an enhanced means for producing strategic analytical products to assist administrative decision-making processes.

There is no cost for joining SoCal LInX. Any costs are being paid for by NCIS except the local connection which in our case would be a virtual server. The virtual server license is already paid for. New World is not being utilized so there will be no fees there.

By approving this motion, the City Council authorizes the City Administrator to execute the MOU with NCIS permitting YPD to join SoCal LInX.
