CALL TO ORDER

Mayor Nicholls called the City Council meeting to order at 5:32 p.m.

INVOCATION/PLEDGE

Pastor Phillip Hayman, Valley Baptist Church, gave the invocation. **Scott Legros**, Police Lieutenant, led the City Council in the Pledge of Allegiance.

FINAL CALL

Mayor Nicholls made a final call for the submission of Speaker Request Forms for agenda related items from members of the audience.

PRESENTATIONS

Chief Irr presented Armando Corona, a civilian from the Yuma community, with a Lifesaving Award for his part in saving the life of his neighbor, Dan Lomax, on August 15th. Corona performed CPR on Lomax, who was in cardiac arrest, until the Yuma Fire Department (YFD) arrived. YFD team members Captain Paco Guzman and Engineer Jordan Simpson were also recognized.

Chief Smith and **Deputy Chief Culp** presented the Yuma Police Department's (YPD) latest recruitment video and a recruitment flyer. The recruitment flyer advertises a \$10,000 hiring bonus for lateral moves as well as incentives YPD can offer including special assignments unique to YPD.

Chief Smith explained that YPD is still experiencing challenges in attracting people to the organization. In the past, YPD has been careful about offering signing bonuses because they felt it was important to take care of the officers currently working. However, adoption of the public safety pay plan by City Council takes care of the current officers. The \$10,000 hiring bonus, which will be paid out in increments over a two-year period, is an attempt to attract talent from other agencies both within and outside of Yuma County

with the thought that an incremental payout will provide some stability and retention of the officers for the two years.

Chief Smith then introduced Sgt. Stephanie Malone handler for K-9 Officer Raiko, who is retiring tonight after a six-year career with YPD. Raiko will live in retirement with Sgt. Malone and her family.

Discussion

- The new Arizona Western College Law Enforcement Training Academy is filling up nicely. The City of Kingman is scheduled for the academy which begins October 7th and Culp is excited to report YPD has six attendees. (Watts/Culp)
- The City of Yuma's own Geoff Montgomery produced YPD's recruitment video; he and his group were thanked for doing a great job. (Shelton/Smith/Mayor Nicholls/Thomas)
- The YPD recruitment video will be played at job fairs and on YPD's Twitter and Facebook accounts. (Nicholls/Smith)
- The most recent recruitment that closed last week had only 76 applicants. That number is not very promising given the number received out of a larger group. Such numbers are causing them to be more creative and go in a different direction such as targeting laterals. (Knight/Smith)
- There have been concerns about the average age of our officers. Targeting laterals is a great way to bring experience in. (Nicholls/Smith)
- The video and flyer are great tools for use by YPD's recruiting officer. (McClendon/Smith)
- One lateral from the Snowflake/White Mountain area started on September 23rd. (Culp/Smith)
