REPORT:

The Yuma City Council, on June 5, 2019 approved the City of Yuma 2019 Annual Action Plan which, in part, set aside HOME funds from the U.S. Department of Housing and Urban Development (HUD) for local nonprofit entities and units of local government to offer affordable housing opportunities to the community. The activities provided through the HOME program further the City's long-standing mission of assisting with housing for its residents with need. The City has negotiated agreements allocating HOME funds totaling \$670,186 to the following local entities:

By approving this motion, the City Council authorizes City Administrator to execute these agreements. The HOME funds awarded by these agreements are a portion of the total HOME allocation received by the Yuma County HOME Consortium for FY 2019-20. The balance of the funding is for activities administered by the Neighborhood Services Division: Housing Rehabilitation - \$210,000; HOME Planning and Administration - \$97,798.
