SUMMARY RECOMMENDATION:

Authorize the City Administrator to execute the necessary documents with the Arizona Companion Animal Spay and Neuter Committee (ACASNC) to accept grant funds to support community spay and neuter surgeries. (Police/Administration) (John Lekan)

REPORT:

Animal Control Services (Animal Control) of the Yuma Police Department is tasked with decreasing the number of stray animals in the community. The ACASNC awarded \$16,000 in grant funding to Animal Control to spay or neuter domesticated and feral animals.

The funds will allow Animal Control to direct \$10,000.00 of the funding to the Humane Society of Yuma (HSOY) for spaying and neutering of domesticated animals and \$6,000.00 of the funding to HSOY for the local community feral cat spay/neuter program. Animal Control will use the grant funds to pay the authorized fees through the voucher program.

All funds must be expended by August 15, 2018, and any unspent funds must be returned with a final follow-up report.

By approving this action, the City Council authorizes the City Administrator to direct YPD and City staff to complete and sign the necessary paperwork to obtain grant funding from ACASNC.
