Summary Recommendation: Adopt the Fiscal Year 2021 Primary Property Tax Levy and Mall Maintenance District Property Tax Levy (Administration/Finance) (Philip Rodriguez/Lisa Marlin)					
REPORT: The City of Yuma Fiscal Year 2021 Adopted Annual Budget is based in part upon an estimated primary property tax levy that is anticipated to raise \$14,215,783 in tax revenue. This estimate is derived from the assessed valuation as of February 4, 2020, provided by the Yuma County Assessor, and multiplied by a tax rate of \$2.3185 on each \$100.00 of assessed valuation. There is no tax rate increase from the Fiscal Year 2020 rate of \$2.3185. City Council adoption of this ordinance reflects an increase of the tax levy by \$254,403, but does not change the tax rate.					
There has been no secondary property tax levy since 1992.					
The tax rate for the Mall Maintenance District is \$3.4152 on each \$100.00 of assessed valuation, which is lower than the Fiscal Year 2020 tax rate of \$4.7398. The levy is anticipated to raise approximately \$110,000 in tax revenues for Fiscal Year 2021.
