Summary Recommendation: Authorize the City Administrator to execute a Facilities Maintenance Agreement (Sublicense) to permit Tuscany of Yuma Lot Owners Association, Phase II, Inc., an Arizona corporation, the use of Yuma County Water Users' Association property under the City of Yuma's License. (Engineering/Jeff Kramer)						
REPORT: The design of Tuscany Medical & Professional Plaza (Phase 2) subdivision provided connections to the existing City water and sanitary sewer utilities located in 21st Drive, and landscaping of City right-of-way adjacent to the development along the west edge of 21st Drive. This area is also located in the United States Bureau of Reclamation Jordan Lateral administered by the Yuma County Water Users' Association (YCWUA). YCWUA issued Encroachment License No. 001-18-001 (the License) to the City of Yuma (City) in April 2018, making the City responsible for the facility use. The License to the City is for construction of a retention basin, water and sanitary sewer connection, landscaping, irrigation system, and maintenance activities related to the described activities. This Facilities Maintenance Agreement will permit Tuscany of Yuma Lot Owners Association, Phase II, Inc., the use of the YCWUA property under the City License for purposes of encroachment, construction, installation, operation and maintenance of water, sewer, retention basin, landscaping, and irrigation. Tuscany of Yuma Lot Owners Association, Phase II, Inc., will assume responsibility for costs related to their use. The Facilities Maintenance Agreement is also subject to the terms contained in the License.
