

REPORT:

The 2020 Census will occur on April 1, 2020. The Census is a mandate of the United States Constitution to complete a count every 10 years of everyone residing in the United States. This includes people of all ages, races, ethnic groups, citizens and non-citizens. The population totals from the 2020 Census will determine the number of seats each state has in the House of Representatives, will be used to redraw state legislative districts, and will determine funding for programs, projects and state shared revenues.

In order to increase the census response rate for the community and ensure that every person is counted, Yuma County is establishing a regional Complete Count Committee (CCC). The CCC will focus efforts to increase the response rate for residents. The CCC will utilize local knowledge, expertise and the influence of each CCC member to design and implement a census awareness campaign targeted to the community, and hard to reach residents. The CCC will be made up of a cross section of community representatives recommended by each jurisdiction.

The United States Bureau of the Census has committed to providing training to the members of the CCC in late summer 2018. Yuma County is requesting recommendations for membership from each jurisdiction within the county. Membership recommendations should be forwarded to city staff designated as coordinators for the 2020 Census, who will share recommendations with Yuma County 2020 Census staff coordinators.
