The alley running through the new Thomas F. Alt Utilities Complex was abandoned by Ordinance O2020-015, adopted by City Council on July 15, 2020. This necessitated a new location for APS to locate their electrical							
service and transformer to serve the Thomas F. Alt Utilities Complex.							
The power feed comes from the south, entering the site underground to eliminate potential overhead electrical hazards to the vehicles, equipment, and personnel expected at the facility. This easement is shown in the attached location map and the easement.
