Bid Award: Residential Commercial Solid Waste Collection and Roll Off Services

SUMMARY RECOMMENDATION:

Award to the lowest responsive and responsible bidder a one-year contract for Residential Commercial Solid Waste Collection and Roll Off Service with the option to renew for four additional one-year periods, depending on the appropriation of funds and satisfactory performance, at an estimated annual cost of \$228,578.00 as needed with the following company:

REPORT:

This contract provides for Residential Commercial Solid Waste Collection and Roll Off Service, specifically for certain city residential customers and city-owned facilities.

This contract is necessary to service front-loading dumpster containers at a limited number of residential customers (duplexes and small apartments) and various parks and City-owned facilities. Roll off container services are used to support ongoing operational and maintenance functions.
