TITLE:

Intergovernmental Agreement: Yuma Union High School District No. 70

SUMMARY RECOMMENDATION:

Authorize the City Administrator, or his designee, to execute an intergovernmental agreement with Yuma Union High School District No. 70 for the School Resource Officer program. (Police/Patrol) (John Lekan)

REPORT:

This is an intergovernmental agreement (IGA) with the Yuma Union High School District No. 70 (District) and the City of Yuma (City) through the Yuma Police Department (YPD) to continue to work cooperatively to further the goals of the District-funded School Resource Officer (SRO) program.

YPD has been providing SROs to the District for over 20 years. A SRO serves as an on-campus law enforcement officer and supports the District by establishing and maintaining a safe learning environment. This IGA will continue to allow YPD to assign four, full-time SROs to the District, one each at Yuma High School, Kofa High School, Cibola High School, and Gila Ridge High School.

Under this IGA, the District shall reimburse the City for the four assigned officers' (a) 10 month full-time salaries, (b) school related overtime expenses up to 50 hours for each SRO, and (c) employee-related expenses. When school is not in session, the assigned officers will return to YPD for assignment.

The IGA has a retroactive effective date of July 1, 2017 and terminates on June 30, 2020. The District has budgeted up to \$328,986.44 for incurred full-time salaries and employee-related expenses for the 2017-2018 fiscal year. A projected budget for each SRO position will be submitted annually to the District before June 30 of each subsequent fiscal year.

By approving this motion, the City Council authorizes the City Administrator to execute the IGA with the District.
