SUMMARY RECOMMENDATION: Award to the lowest responsible and responsive bidder for the renovation of the Joe Henry Optimist Center in the amount of \$161,625.20 to: Taylor Engineering, PLLC Yuma, Arizona (Engineering / Parks - Bid #2017-20000079) (Jay Simonton) REPORT: A priority objective of the revitalization plan for the Mesa Heights neighborhood is to provide recreational opportunities for low-income youth, especially during summer. The park and gymnasium at Joe Henry Optimist Center represent a perfect venue for this type of programming, but the lack of air conditioning at the gymnasium hampered the ability to provide activity year-around. Community Development Block Grant (CDBG) funds were designated for installation of air conditioning, and CIP funding was added to supplement the total project cost. This contract includes: Installation of two air conditioner systems; An upgrade to the electrical system to provide higher capacity power feeds for the new HVAC units; Insulation for the walls and ceiling and new doors in order to meet current energy efficiency standards; 					
 Removal of existing evaporative coolers. Staff has chosen to select the alternate number 2, which is the removal of all existing double doors and replace with more energy efficient doors, in addition to the base bid.
