Preannexation Development Agreement: Aguilar

SUMMARY RECOMMENDATION:

Authorize a Preannexation Development Agreement with Eliceo Aguilar for property located at 909 S. Dora Avenue. (Community Development/Community Planning) (Laurie Lineberry)

REPORT:

Eliceo Aguilar is the owner of a parcel located at 909 S. Dora Avenue (APN 664-06-105). The property is located outside the City of Yuma and is undeveloped. The owner intends to construct a single-family home on the property and has requested water service from the City of Yuma.

In accordance with City policy, they have also requested annexation so that the property may receive water service. However, the property does not meet the minimum requirements under state law for annexation. Accordingly, as annexation of the property is not possible at the current time, a Preannexation Development Agreement will be executed, kept on file, and utilized at such time that a larger annexation can be brought forward.

The attached resolution authorizes a Preannexation Development Agreement with Eliceo Aguilar to provide for the additional water service and require connection to City sewer at such time that sewer is available.
