CALL TO ORDER

Mayor Nicholls called the City Council meeting to order at 5:32 p.m.

INVOCATION/PLEDGE

Pastor George Boundey, 7th Day Adventist Church, gave the invocation. **Susan Smith**, Deputy Chief of Police, led the City Council in the Pledge of Allegiance.

FINAL CALL

Mayor Nicholls made a final call for the submission of Speaker Request Forms from members of the audience.

PRESENTATIONS

Recognition of Citizen Support

Chief Irr recognized Nathan Alleyne, Albert Lopez, Adam Olivarez, and Hendrix Orzal from DaVita Dialysis for their efforts in assisting a person who had become unresponsive in the parking lot outside of their place of business. Using CPR and an Automated External Defibrillator (AED) they were able to revive the patient by the time the crew from the Yuma Fire Department (YFD) arrived on the scene.

Chief Irr and **Captain Deanda** recognized Dr. Edward Boehringer, Carlos Gaxiola, Kenia Berna, Vanessa Quemal, and Luis Gerardo Castro Roa from Yuma Dentistry 4 Kids who also assisted a person who was found unresponsive behind their place of business. They had to make their way over a fence to access the patient and administered CPR and utilized an AED until YFD arrived.

Board & Commission Quarterly Recognition

Mayor Nicholls recognized Leslie McClendon for her participation on the Merit System Board. In addition to stepping in to fill an unexpired term on this board she also served as councilmember on the Yuma City Council from 2008-2015.

Recognition of Achievement for Excellence in Financial Reporting

Mayor Nicholls presented the Government Finance Officers Association award for excellence in financial reporting to Accounting Manager Lisa Marlin, who received the award on behalf of Finance Director Pat Wicks. This is the 34th consecutive year that the City has received this award.

Yuma Boxing History Day Proclamation

Mayor Nicholls read a proclamation declaring July 19, 2017, as Yuma Boxing History Day in recognition of the contributions that the sport of boxing has made in building character in countless young people for many generations.

I. MOTION CONSENT AGENDA

Motion Consent Agenda Item B.6 – Cooperative Purchase Agreement: Automated Side Loaders (authorize the purchase of three solid waste collection trucks at \$297,630.85 each for a total cost of \$892,892.55) (Public Works)

Wright asked if the last trucks that were replaced were at a similar cost or if the cost has increased since that time. **Olea** stated that the last two replacements were approved last fiscal year were approximately the same cost. **Wright** asked if a warranty is included in the purchase price. **Olea** stated that a warranty is included that covers the trucks for one or two years. **Wright** asked what the status of the solid waste fleet will be once these three trucks are replaced. **Olea** stated that two trucks are scheduled to be replaced in Fiscal Year 2019 and two more trucks in Fiscal Year 2020; after that, the fleet will be in good condition. He added that these trucks are being purchased and serviced locally. **Wright** asked what the typical lifecycle is of a solid waste truck. **Olea** stated that the City is expecting a minimum of eight to ten years from the new trucks.

Miller shared that he reached out to a local waste disposal company who confirmed that in the event the City chooses to privatize trash collection they would purchase the City's equipment as part of taking over that service.

Mayor Nicholls asked if the funds for this purchase will come out of the Solid Waste Enterprise Fund. **Olea** confirmed that is correct.




