TITLE:

Intergovernmental Agreements: Arizona Department of Public Safety (DPS) Gang and Immigration Intelligence Team Enforcement Mission (GIITEM)

SUMMARY RECOMMENDATION:

Authorize the City Administrator to enter into two related Intergovernmental Agreements (IGAs) between City of Yuma Police Department (YPD) and DPS GIITEM wherein: 1) YPD agrees to the assignment of one sworn officer to liaison with the GIITEM task force; and, 2) DPS agrees to provide access to AZ GangNet and YPD agrees to enter documented gang information collected into the system. (Police/Patrol) (John Lekan)

REPORT:

YPD and DPS GIITEM intend to enter into two related IGAs to assist with law enforcement operations: AZ DPS Contract Nos. 2018-73 and 2018-74.

The first IGA (AZ DPS 2018-73) assigns one (1) sworn law enforcement officer from YPD to DPS GIITEM, to act as a liaison between the two agencies. This officer would attend some DPS GIITEM training and participate in joint operations and local details with GIITEM. The YPD officer remains with the Yuma Police Department but will be attached to GIITEM with the purpose of enhancing law enforcement services concerning the criminal activities of street gangs, through the cooperative efforts of the parties to this IGA.

The second IGA (AZ DPS 2018-74) is a Memorandum of Understanding to continue YPD's existing subscription to a gang-tracking database known as AZ GangNet. AZ DPS creates and maintains AZ GangNet to share criminal gang information between participating agencies and jurisdictions. As a participating agency with access to the gang database, YPD agrees to enter all persons who have been documented as criminal street gang members and/or associate members pursuant to A.R.S. §13-105.8 into the AZ GangNet database.
