Mayor Nicholls called the City Council meeting to order at 5:33 p.m.

Check Presentation from Cenpatico Integrated Care

**Maria Chavoya,** Regional Manager from Cenpatico Integrated Care presented a check in the amount of \$10,000 to the City of Yuma for community re-investment funding that has been designated to the Anti-Meth Yuma Campaign.

#### I. MOTION CONSENT AGENDA

<u>B.5</u> Contract Increase: Professional Design Services for Pacific Avenue Athletic Complex -Authorize the execution of a change order to increase the current contract in an amount not to exceed \$175,000 to Kimley-Horn and Associates, Inc., for post-design services for the Pacific Avenue Athletic Complex. (Parks and Rec/RFQ #2016-20000104) (Scott/Wilson)

**Mayor Nicholls** declared a conflict of interest, turned the meeting over to Deputy Mayor Craft and left the dais.

Due to some misinformation in the paper, Knight requested clarification on the need for this contract increase from the original \$149,000 with Kimley-Horn for post design services. Scott explained the City would like Kimley-Horn to have a bigger presence on site during construction to help with writing the addenda, answering questions on plans and specification and record drawing since the original proposal included limited the site visits to and limited weekly construction meeting attendance. He emphasized that this is not a project budget increase; in fact, the City is still under the estimates that were put together when the budget was approved. Knight asked if it would be detrimental to go forward without post design services. Scott responded that the City does not have the expertise when it comes to mechanical engineering elements, electrical engineering, architecture and landscape architecture. While we may be able to supplement with the use of some of our on-call contracts on a limited basis, there are limits we cannot exceed by state law. Knight asked if a lack of design services would cause construction to be delayed or halted. Wilkinson stated that construction would continue however there would be issues to consider. Scott added that the biggest risk would be to the project schedule and the quality of the finished project. Knight opined that it would be very short-sighted to risk possible construction mistakes to save \$175,000 on a multi-million dollar project. Wilkinson noted that a similar situation occurred which ended up requiring an additional year to fix the project. In response to a question asked by Councilmember Wright at last night's meeting regarding whether the city could select the best company for a project without an interview, based on information provided by the Purchasing and Contracts Manager, a company score is not significantly affected by the interview.

Miller asked if Kimley-Horn is still under contract for post-design services. Scott stated that they were. Miller asked if there were any changes in the design during the design process. Scott stated that there were 3 or 4 design changes. Harris added that the original post design as Josh mentioned was significantly scaled back because they did not know if the design team was going to be able to administer construction. Miller asked if the City has engineers with expertise in post design work. Harris explained that the engineering department within the City is staffed with civil engineers who primarily specialize in horizontal construction such as roadways, water lines, and sewer lines. Shelton asked if it would be acceptable to postpone this item to better provide council with a breakdown of where these monies would go. Scott responded that the additional \$175,000 is a maximum amount and the city is not committed to spend the entire amount. He emphasized his confidence in the engineering department and their ability to manage and oversee this project, but Council can be provided with a breakdown of with a breakdown of where these monies would go.

**Motion**(Knight/Wright) to continue this meeting upon completion of the rest of this agenda to Tuesday the 25<sup>th</sup> of October at 5:30 p.m. Voice Vote: **approved** 6-0-1 Mayor abstained due to a conflict of interest.

Mayor Nicholls returned to the dais.

### V. PUBLIC HEARING AND RELATED ITEMS

### Public Hearing opened at 6:29 p.m.

<u>R2016-034</u> General Plan Amendment: 2016 Parks & Recreation Master Plan – Approve the request to adopt the 2016 Parks & Recreation Master Plan and amend the City of Yuma 2012 General Plan to incorporate the Master Plan. (DCD/Planning) (Lineberry)

**Wendt** presented an overview of the Parks and Recreation Master Plan that included process, analysis, and conclusions as well as recommendations provided by Council at last night's worksession. The purpose and mission were broken down into five different strategies; assess the current facilities, public outreach and input, analyze and edit the information, create a long range plan, and create a detailed implementation plan. The document overview is likewise broken up into five sections; executive summary, existing facilities, community trends, desired facilities, and level of service analysis.

**Leeman** explained that the long range plan is largely the same as the former plan with the exception of the proposed projects and desired facilities. Based on comments heard last night the North and South Mesa Community Parks will be moved to the mid-range timeline and other projects will be phased in as funding becomes available. There will also be future discussions of the basin near Walmart with Engineering to look at other use possibilities. The last section is the implementation plan which includes an action plan and a list of funding sources.

Wendt mentioned that they met with the Parks Arts and Recreation Commission six times before the plan was approved. She stated that the City has been doing public outreach since June including the City website, Parks & Recreation email contacts, and approximately 54 agencies within Yuma County; such as City of San Luis, Somerton, Bureau Of Reclamation, Arizona Game & Fish, the Bureau of Land Management, all of the school districts and Arizona Public Service to name a few. Some of the public comments that were received were recommendations for youth and adult soccer fields, basketball courts, hockey rinks, as well as other programs and facilities. The citizen's also expressed concern about a property tax increase. Additionally, the irrigation district would like to receive advanced notice so they could be part of the process with anything dealing with the East and West Main Canals, and possible expansion along their irrigation districts.

**Wright** asked if any public comments were recieved on the parking and the availability of Smucker Park. **Wendt** stated that it is proposed on the long range plan to be reviewed, but ultimately it is based on funding availability.

**Motion** (Knight/Craft) to amend Resolution R2016-034 Exhibit A of the Parks and Recreation Master Plan and Chapter 4 of the City of Yuma 2012 General Plan to change the timeline for the North Mesa Community Park from Long-Term (10+ years) to Short-Term and the South Mesa Community Park project from Long Term (10+ years) to Mid-term (5-10 years). Voice Vote: **approved** 7-0.

**Motion** (Knight/Thomas) to close the public hearing. Voice vote: **approved** 7-0. The Public Hearing was closed at 6:49 p.m.
