Grant Agreement: City of Tucson High Intensity Drug Trafficking Area Grant

SUMMARY RECOMMENDATION:

Authorize the City Adminstrator to execute an agreement with the City of Tucson for High Intensity Drug Trafficking Areas (HIDTA) grant program to support the officer assigned to the U.S. Marshals Arizona Warrant Apprehension Network and Tactical Enforcement Detail (WANTED). (Police/Admin) (John Lekan)

REPORT:

The City of Yuma, through the Yuma Police Department, currently participates in the U.S. Marshals' Service District Fugitive Apprehension Task Force, also known as the Arizona Warrant Apprehension Network and Tactical Enforcement Detail (WANTED) Task Force. The primary mission of the Task Force is to investigate and arrest, through joint law enforcement operations, persons who have active local, state, and federal warrants for their arrest. The Yuma Police Department has one sworn police officer assigned to the WANTED Task Force.

Federal funds have been made available from the Office of National Drug Control Policy that are to be used to support and enhance activities in accordance with the approved HIDTA initiative. The City of Tucson has fiduciary duties for the funds and has made available to the City of Yuma \$6,000.00 in overtime funds for the officer assigned to the WANTED Task Force. Payment of the funds is made through reimbursements and no matching funds are required from the City. The term of the grant begins January 1, 2017 and terminates December 31, 2018.

By approving this motion, the City Council authorizes the City Administrator to execute the HIDTA grant.
