CALL TO ORDER

Deputy Mayor Knight called the City Council meeting to order at 5:30 p.m.

INVOCATION/PLEDGE

Pastor Joe Avila, Community Christian Church, gave the invocation. **Ron Corbin**, Deputy City Administrator, led the City Council in the Pledge of Allegiance.

FINAL CALL

Deputy Mayor Knight made a final call for the submission of Speaker Request Forms for agenda related items from members of the audience.

PRESENTATIONS

Deputy Mayor Knight read a Proclamation proclaiming the month of October 2017 as Community Planning Month in the City of Yuma in conjunction with the celebration of National Community Planning Month.

Wilkinson continued the presentations stating that two years ago Yuma Area Benefit Consortium (YABC) selected the Wellness Council of Arizona to provide the City with a Health and Wellness Coach in an effort to reduce long term healthcare costs. A volunteer group of employees, known as the Wellness Ambassadors, along with the Health and Wellness Coach work together to create programs and run events to help improve the health of City staff. Programs include weight loss challenges, blood pressure checks, nutrition classes, exercise and yoga classes and walking and water challenges. The program has helped employees lose weight, lower their blood pressure and cholesterol levels, improve their physical fitness, and manage stress.

On September 15, 2017, the City was widely recognized at the Wellness Council of Arizona's 32nd Annual Meeting and Awards Celebration. **Wilkinson** introduced the following winners:

- Ron Corbin Senior Leadership Champion
- Cara Smothers Wellness Committee Champion
- Frankie Vasquez Personal Achievement Champion
- Rob Duffy and the Wellness Ambassadors Workplace Process and Leadership

Corbin expressed how impressed he was with the group and stated that at the last weight loss challenge, City employees lost over 700 pounds. They also identified those employees with high blood pressure, resulting in early intervention which will help to reduce costs and keep premiums at a low. **Corbin** commended the team for their great efforts.

Finally, **Wilkinson** played a Public Service Announcement video on recycling titled: Out of the Green, Into the Blue which was videoed, produced and directed by Geoff Montgomery, Video Production and Operations Specialist with the City of Yuma. The video features Montgomery's son, Oliver. **Wilkinson** recognized Montgomery who received the following awards:

- 2nd Place in the category of Public Service Announcement for operating budgets under \$200,000 by the National Association of Telecommunications Officers and Advisors.
- An Award of Excellence with the City/County Communications and Marketing Association at its annual conference in the category for cities with populations under 100,000.

II. RESOLUTION CONSENT AGENDA

<u>Resolution Consent Agenda R2017-028</u> – Adopt a resolution supporting the application for a Transportation Investment Generating Economic Recovery (TIGER) Grant to complete the development of a Multi-Modal Transportation Center (Center) in downtown Yuma at the historic Hotel Del Sol. (Admin)

Shelton stated it would be his desire to see the Hotel Del Sol restored to some level of usability and restored to the private sector. Further, **Shelton** stated he had no problem with the bus transport side. However, he opined the railroad has done little to no upgrades to make their facilities more customer friendly and have not been communicative with the public.

Wright asked if other floors of the Hotel Del Sol can be used and if other commercial usage at this site would meet the criteria for this grant. **Neinast** confirmed it would, and that the long term intent is to bring private industry into the area. **Wright** asked if commitments have been received from the railroad, bus and other businesses who will benefit from this Center. **Neinast** replied that the Yuma County Intergovernmental Public Transportation Authority (YCIPTA) currently handles the Greyhound portion of our transportation here in Yuma. That activity will transition to downtown. Amtrak is not participating at this time, but discussions are still underway. The intent of bringing the Amtrak portion in is for the safety of our citizens to have a safe facility to house them while they wait for their trains that arrive and leave in the middle of the night. In response to **Wright's** question, **Neinast** stated the Hotel Del Sol site was selected during a transportation feasibility study that looked at 16 sites. Many factors played into the selection of the Hotel Del Sol including proximity to the railroad, Interstate 8, the bus transportation system, large employment centers and the build-out of our bike systems as well as economic development and revitalizing downtown.

Thomas asked what other intended uses the City has for this hotel if we do not use it as a transportation center. **Wilkinson** responded that if we do not get outside federal funding it is not a project that the City would take on by itself.

Miller questioned where the City's 20% of the funding would come from if the TIGER grant is awarded. **Wilkinson** responded that the grant application lists the 2% fund. However, any public-private partnership can be used towards that match.

Motion (Thomas/Craft): To adopt the Resolution Consent Agenda as recommended.
