Call of Election: City of Yuma 2019 Primary and General Election

SUMMARY RECOMMENDATION:
Approve a Call of Election for the 2019 City of Yuma Primary and General Elections to be held August 27, 2019 and November 5, 2019, respectively. (City Administration/City Clerk) (Lynda L. Bushong)

REPORT:
The City of Yuma Primary Election will be held on Tuesday, August 27, 2019 for the purpose of nominating and/or electing candidates for the following:

- Councilmembers – three seats available
- Municipal Judge – one seat

The General Election will be held on Tuesday, November 5, 2019 for the purpose of electing the candidates that have not been declared elected at the Primary Election.

Candidate nomination packets have been available on the City's website and at the Office of the City Clerk, located at Yuma City Hall, One City Plaza, beginning March 11, 2019. The first day for candidates to file nomination documents was Monday, April 29, 2019 and the last day to file nomination documents is Wednesday, May 29, 2019 at 5:00 p.m.

Candidates who are elected to the above noted positions will serve a four-year term beginning January 1, 2020 and ending December 31, 2023.
