<u>Motion Consent Agenda Item B.9</u> – Intergovernmental Agreement: Yuma County Election Services: Approve an Intergovernmental Agreement (IGA) between the City of Yuma, Yuma County and the Yuma County Recorder for the provision of election services. (Admin/Clerk)

**Motion** (Craft/Knight): That item B.9 the Intergovernmental Agreement with Yuma County Elections Services be amended as follows:

Section II, paragraph 3(a) is amended to read: "Notify the County no later than 120 days prior to the election date to conduct the election."

The first sentence in Section III, paragraph 1 is amended to read:

"This Agreement shall be effective as of January 1, 2017, and shall remain in full force and effect for a term of five years from the Effective Date (Initial Term), unless terminated as otherwise provided in this Agreement" and The "In Witness Whereof" clause above the signature lines shall be amended to read: "In Witness Whereof, the parties have executed this Agreement the day and year written below."

Voice Vote: approved 7-0.

Motion Consent Agenda Item B.6 – Bid Award: Main Street Water Treatment plant Filters 1-4 Rehabilitation / Upgrades – Award to the lowest responsible and responsive bidder for the construction of the Main Street Water Treatment Plant Filters 1-4 Rehabilitation / upgrades in the amount of \$2,357,048.98 to: LPC Construction, Inc., Yuma Arizona (Utilities – Bid #2017-20000118)

**Wright** asked what prompted the Utilities Department to have this on the schedule on this budget year and what are the indicators that these 4 filters need to be upgrades? **Simonton** explained that in 1998/1999 there was a failure of filter number 1. It collapsed the underdrain support system, causing a major catastrophe. Filters 2, 3, and 4 are the same age; almost 50 years old. **Simonton** stated that this project has been in the Capital Improvement Program (CIP) for more than 10 years now. Utilities has tried to get it programmed, but have been unable to afford it. Originally this project was going to be constructed all in one phase; however it has been spread out to three phases over a six year period. **Wright** expressed concern for having sufficient funding to pay for emergencies after this expense. **Wicks** responded that the City carries a fund balance in the water fund that is intended specifically to handle emergencies, operations and routine maintenance.
