SUMMARY RECOMMENDATION: Authorize the City Administrator to accept a grant award from Arizona Complete Health in the amount of \$25,000.00 to support the City's Emergency Home Repair Program. (City Administration) (Laurie Neinast)					

## REPORT:

Arizona Complete Health (formally Cenpatico) is committed to improving the health and safety of the Yuma community.

The City of Yuma (City) submitted a request to Arizona Complete Health requesting \$25,000.00 in funds to help support the City's Emergency Home Repair Program; a program that addresses housing conditions that pose a threat to the health, safety and welfare of residents of owner-occupied homes. This program is administered by the Department of Community Development (DCD).

The City's Building Inspectors and Code Enforcement Officers frequently encounter homeowners with serious housing problems, such as inoperable plumbing, leaking roofs, or unsafe wiring, but they lack the financial resources to make repairs. Significant code problems such as these make the home unsafe for occupancy, and may cause homelessness.

Other housing rehabilitation programs administered by DCD are unable to respond to emergency situations and have specific requirements for eligibility of the homeowners. The Emergency Repair Program has flexible administrative terms and offers priority assistance to the elderly, families with children, and veterans.
