SHAPING YUMA'S FUTURE: VISION AND STRATEGIC OUTCOMES

Since 2020, the Yuma City Council has held an Annual Council Retreat to develop, review, and update the City's Strategic Plan. These sessions give the Council time to step away from daily business, focus on long-term priorities, and ensure the City's vision and strategic outcomes remain relevant to community needs and aspirations.

In March 2025, the Council reaffirmed its commitment to the existing Vision Statement and the five (5) strategic outcomes that guide Yuma's



future. Councilmembers reviewed the definitions for each outcome, reached consensus on an updated definition for Safe & Prosperous, considered progress on current initiatives, and identified new priorities to better align with the strategic outcomes.

This plan reflects the priorities, updated language, and initiatives that emerged from those conversations.

PURPOSE OF A CITY'S STRATEGIC PLAN

A city's strategic plan is more than a document—it is a shared roadmap for the community's future. It defines a clear vision, sets long-term priorities, and establishes measurable goals to guide decision-making. By identifying strategic outcomes and priority initiatives, the plan helps ensure that resources are used effectively, opportunities are pursued intentionally, and challenges are addressed proactively.

For the City of Yuma, the Strategic Plan serves several key purposes:

- Provides direction for policy decisions, capital investments, and program development.
- Aligns efforts of the City Council, staff, and community partners toward common goals.
- **Promotes accountability** by setting priorities that can be measured and reported on over time.
- **Strengthens resilience** by anticipating future needs and positioning the City to respond effectively to change.
- Engages the community by connecting residents to the City's vision and demonstrating progress toward shared outcomes.

When used consistently, the Strategic Plan becomes a living framework—helping the City adapt to changing circumstances while staying focused on the long-term vision for Yuma's future.

PURPOSE OF THE ANNUAL COUNCIL RETREAT

Since 2020, the Yuma City Council has met annually for a Council Retreat to develop, review, and update the City's Strategic Plan. The retreat fosters collaboration between Council and staff, strengthens the ability to work together effectively, and creates space for candid, forward-looking conversations.

It is a dedicated time to review progress on strategic initiatives, identify emerging opportunities and challenges, and confirm the shared direction for the City—ensuring resources are aligned with what will have the greatest impact on Yuma's future.

and initiatives discussed during the small group discussions. From there, Council participated in a ranking exercise ("dot voting exercise") and based on interest (number of dots received) the initiatives were categorized as top priority, high priority, or other priority.

Based on this exercise, the Council identified several new initiatives to support each strategic outcome. The updated language and new initiatives have been incorporated into this document.



A LIVING PLAN: HISTORY AND EVOLUTION

In 2020, the City Council recognized the need for an updated and actively managed Strategic Plan. At the time, the City's most recent strategic management document dated back to 2002. To launch this effort, the Council held a Vision and Goal Setting Retreat in October 2020. With the support of an outside facilitator, the Council and members of the Executive Leadership Team created a plan that reflected Yuma's unique history and its desired future.

The planning process was shaped by extensive community input. In the weeks leading up to the retreat, the City hosted a listening tour—Your Insights, Yuma's Future—with public sessions across the community, along with an online survey. Residents and business owners shared their perspectives on Yuma's strengths, challenges, and priorities for the future. This feedback was provided to the Council during the retreat and played a key role in shaping the plan.

At the conclusion of the 2020 retreat, the Council adopted a Vision Statement, five strategic outcomes, and a set of priority initiatives for each outcome. The Strategic Plan was formally adopted on December 16, 2020.

Since then, the City Council has met annually to review and update the plan—ensuring it remains a living document that reflects progress, responds to emerging challenges, and stays aligned with the community's evolving needs.

HOW THE 2025 RETREAT SHAPED THE PLAN

On March 24 and 25, 2025, the City Council held its Annual Council Retreat to review the Strategic Plan and engage in strategic conversations about Yuma's future. Councilmembers reaffirmed the current Vision Statement and five (5) strategic outcomes, discussed updated definitions, and reached consensus on a revised definition for Safe & Prosperous.

Over the two days, the Council reviewed progress on existing initiatives, identified new priorities, and discussed funding considerations. Strategic topics included water resources, economic development, infrastructure, parks and recreation, and public safety. The retreat concluded with agreement on which initiatives should be incorporated into the Strategic Plan for alignment with the strategic outcomes.



COMMUNITY ENGAGEMENT

The City of Yuma engages with residents through both formal and informal channels to gather input and share information. Formal opportunities include public meetings, open houses, surveys, and other structured outreach efforts. Information is also shared through news releases, television, the City's website, and other online platforms. Informally, Councilmembers and staff connect with residents at community events and in everyday conversations.

These ongoing interactions help ensure the Strategic Plan reflects the community's priorities and remains responsive to Yuma's changing needs.



LOOKING AHEAD

The Strategic Plan is a living guide for the City of Yuma's work and decision-making. As we move forward, the City Council and staff will continue to use this plan to set priorities, align resources, and track progress toward our shared vision. The status of initiatives will be reviewed and updated each year, and new opportunities and challenges will be considered as they arise.

Ongoing community input—through public meetings, outreach events, online engagement, and everyday conversations—will remain central to this process, ensuring the Strategic Plan stays focused, responsive, and reflective of what matters most to our community.
