**REPORT:**

The City has established and allocated funds for the road and utility improvements to 1<sup>st</sup> Avenue between 24<sup>th</sup> and 26<sup>th</sup> streets. The existing infrastructure is in poor condition, making these roads and utility system improvements a priority to both the Public Works and Utilities departments.

Under the contract, Cemex Construction Materials South, LLC will be responsible for the construction of all improvements, including but not limited to pavement, waterline and manhole replacements. The improvements will increase the quality of services provided to the residents in the vicinity of the project.
