<b>SUMMARY RECOMMENDATION:</b> Adopt the official canvass of the November 3, 2020, City of Yuma Special Election. (City Administration/ City Clerk) (Lynda L. Bushong)					
<ul> <li>REPORT: The City of Yuma Special Election was held on Tuesday, November 3, 2020, for the purpose of referring the following two questions to the qualified electors pursuant to the recommendation made by the Charter Review Committee:</li> <li>Proposition 412 – Amend the Yuma City Charter to conform to state law consolidating elections to even-numbered years and align City elections for Mayor, Councilmembers and Municipal Judges with the state election cycle.</li> <li>Proposition 413 – Amend the Yuma City Charter to align the deadline for the submission of primary election nomination petitions with state elections law.</li> </ul>					
Article IV, Section 9 of the Yuma City Charter and Arizona Revised Statutes (A.R.S.) § 16-642(A), requires the City Council to declare the results of an election by resolution not less than six days and not more than 20 days following the election. A.R.S. § 16-646 requires the official canvass to contain certain information, which has been included in the resolution.					

The City must comply with the Arizona Revised Statutes in accordance with Arizona law. The 2020 Canvass of the Special Election meets the Respected and Responsible strategic outcome.
