<u>O2016-022</u> City of Yuma 2016 Special Election: – Call a special election to be held the same time as the City of Yuma General Election on November 8, 2016 to submit to those persons qualified to vote in the City of Yuma the question of increasing the Transaction Privilege Tax levy by three-tenths of one percent (0.3%). (Admin)

Discussion

Wright stated he read an editorial in the Yuma Sun that may have caused some confusion about the sales tax proposal. He expressed those concerns to Greg Wilkinson and asked if Mr. Wilkinson could clarify to the public to help ease the confusion about the ordinance. **Wilkinson** clarified the difference between the levy (the dollar amount the City receives) and the tax rate (percentage assessed on a property's value). He also explained that while the levy may not increase outside of the City's natural growth, the rate may still fluctuate. The Truth in Taxation Rate does not include the 2% that the City is allowed to raise in property taxes each year.
