The Mayor and City Council expressed their appreciation to the individual Yuma Legislative Team for the opportunity to meet and discuss issues that affect the City of Yuma. They met with the Yuma legislators at the below noted times and focused their discussions on the following four issues:

- 1. State of City Infrastructure Roads
 - By 2022, Yuma will have 128 miles of failed or failing roads
 - Cost to abate conditions and make acceptable is \$84 million
 - Need comprehensive resolution revenue is matter of statewide concern
 - o Larger revenue sources are needed
- 2. Protections Military Facilities
 - Marine Corps Air Station (MCAS) Yuma
 - o HB 2310 Yuma County Fairgrounds relocation funding
 - o Zoning (base protection act A.R.S. § 28-8481)
 - Yuma Proving Grounds (YPG)
 - o Funding for U.S. Highway 95
- 3. Governor's Support for Rural Communities
 - Rural Broadband (Support)
 - HB 2311 wireless providers, removing exemption
 - HB 2030 placing another layer of bureaucracy at border inspections
 - HB 2814 creating a much-needed rural economic improvement programs
- 4. Local Issues need Local Solutions while Statewide Issues need Statewide Solutions
 - Local Representatives can handle:
 - O Zoning; local fees; blight; local police issues; retaining lawyers; rights-of-way
 - Statewide Solutions to Statewide Problems:
 - Keep field even, create opportunities for all communities, including rural; public safety funding
