Standard Form Consent Agreements: Bureau of Reclamation and Yuma Mesa Irrigation and Drainage District

SUMMARY RECOMMENDATION:

Authorize the City Adminstrator to enter into standard form Consent Agreements with the Bureau of Reclamation and Yuma Mesa Irrigation and Drainage District for the construction, operation and maintenance of City utility and roadway infrastructure on Bureau of Reclamation rights-of-way. (Engineering/Administration) (Jay Simonton)

REPORT:

From time to time, the City of Yuma (City) needs to access or expand utility and roadway infrastructure upon rights-of-way maintained by other entities. Previously, the City adopted Resolution R2015-031, authorizing the City Administrator to enter into standard form license agreements with the Yuma County Water Users' Association (Association) in order to streamline the process of obtaining approval to construct, operate and maintain City infrastructure within the Association's rights-of-way.

Similar to the Association license agreements, this proposed resolution authorizes the City to enter into a Consent Agreement with the Bureau of Reclamation and Yuma Mesa Irrigation and Drainage District for the construction, operation and maintenance of certain City infrastructure. In order to streamline the process in the future, the City desires to approve this form as a standard form Consent Agreement that will allow the City Administrator to execute future Consent Agreements with the Bureau of Reclamation and Drainage District similar to license agreements with the Yuma County Water Users' Association.

The current Bureau of Reclamation Consent Agreement - Contract No. 17-07-34-L1896, authorizes the construction, operation and maintenance of a 20-foot wide secondary emergency public access lane within the Bureau of Reclamation's right-of-way for the B-1.7 Lateral in connection with the Kerley Ranch Unit No. 3 Subdivision.
