Bid Award: Main Street Water Treatment Plant Filters 1 - 4 Rehabilitation / Upgrades

SUMMARY RECOMMENDATION:

Award to the lowest responsible and responsive bidder for the construction of the Main Street Water Treatment Plant Filters 1 - 4 Rehabilitation / Upgrades in the amount of \$2,357,048.98 to:

LPC Construction, Inc. Yuma, Arizona

(Utilities - Bid #2017-20000118) (Jay Simonton/Robin R. Wilson)

REPORT:

The existing filter and backwash system is more than 40 years old. Potential failure is possible due to the age of the structures and equipment. System failure may result in lengthy service interruption for a majority of the City's water customers.

The base bid work will include new filter underdrain support system and new media for filters 1-4, repairing the underdrain gallery, installing new meters, and new system controls.

Alternate 1 work includes a new air backwash blower with accessories and upgrading the backwash air service.

Based on funding available, staff is recommending City Council award the base bid and Alternate 1 by approving this motion.
