TITLE: Job Order Authorization: Fire Station No. 2					
Summary Recommendation: Authorize the City Administrator to execute a Job Order with Cemex Construction Materials South, LLC, in an amount not to exceed \$266,141.83, for capital improvements to Fire Station No. 2. (Engineering) (Jeffrey A. Kramer)					

REPORT:

The City intends to issue a job order to Cemex Construction Materials South, LLC (Contractor) pursuant to City Job Order Master Contract #2019-20000036 - Transportation Facilities, Pathways and Pavement (JOC Contract), awarded December 5, 2018.

Pursuant to the JOC Contract, the City issues a separate job order for each project assignment. The JOC Contract sets forth the general terms and conditions governing all job orders issued under the contract, with each job order providing the individual project's scope of work and any additional terms and conditions specific to the project.

Under the proposed job order, the Contractor will remove and replace the concrete parking lot at Fire Station No. 2 (3284 S. Ave A). Work will include remove/replace the existing concrete paving and restripe parking spaces to match existing. Existing concrete curbs, sidewalks, and valley gutters shall remain in place and be protected during construction. Finished grades shall match existing drainage patterns and shall direct runoff away from all building structures.

The job order requires the Contractor to complete the project within 60 days after the notice to proceed is issued. The job order price worksheet is attached.

By approving this motion, the City Council authorizes a job order for the referenced project pursuant to the approved JOC Contract.
