Grant Award: Assistance to Firefighters Grant - Fire Prevention and Safety Grant

SUMMARY RECOMMENDATION:

Authorize the City Administrator to execute the required documents for the Assistance to Firefighters Grant Program - Fire Prevention and Safety Grant Agreement No. #EMW-2016-FP-00225 to receive grant funding in the amount of \$10,000.00. (Fire/Community Risk Reduction) (Steve Irr)

REPORT:

The U.S. Department of Homeland Security/FEMA, through the Assistance to Firefighters Grant Program–Fire Prevention and Safety Grant agreement, #EMW-2016-FP-00225 (Fire Prevention Grant), has awarded the City of Yuma \$10,000.00 to purchase smoke alarms and fire prevention educational materials.

The purpose of the Fire Prevention Grant is to protect the health and life safety of the citizens of Yuma, as well as firefighting personnel against fire and fire related hazards. The Community Risk Reduction Division (CRR) will purchase long-life smoke alarms to install in at-risk homes, along with providing educational materials/awareness in English and Spanish to citizens of the Yuma community. This will be achieved through various CRR programs, including partnerships with other supporting organizations such as the American Red Cross, City of Yuma Neighborhood Services, and Yuma County Community Emergency Response Team (CERT). At-risk homes include those without working smoke alarms, outdated smoke alarms, or inadequate smoke alarm protection.

Under the terms of the Fire Prevention Grant, the City is required to provide matching funds in the amount of \$500.00, or 5% of the awarded amount. The City must use the funds by August 10, 2018.

By approving this motion, the City Council authorizes the City Administrator to execute the documents necessary to accept the Fire Prevention Grant.
