SUMMARY RECOMMENDATION:

Approve a Special Event Liquor License application submitted by Barry Olsen on behalf of Caballeros de Yuma, Inc., for the Colorado River Crossing Balloon Festival. The event will take place at Desert Sun Stadium, 1280 W. Desert Sun Drive, on Saturday, November 23, 2019, from 11:00 a.m. to 11:00 p.m. (SP19-30) (City Administration/City Clerk)

REPORT:

Barry Olsen, on behalf of Caballeros de Yuma, Inc., has applied for a Special Event Liquor License for the Colorado River Crossing Balloon Festival. The event will take place at Desert Sun Stadium, 1280 W. Desert Sun Drive, on Saturday, November 23, 2019, from 11:00 a.m. to 11:00 p.m.

As per State Liquor License requirements, the Yuma Civic Center and the Caballeros de Yuma, Inc. have agreed to suspend the portion of their liquor license pertaining to Desert Sun Stadium on the dates and times listed above.

The application has been reviewed by Community Development, the Police Department, the Fire Department, Risk Management, and City Engineering (Traffic). No objections have been received.

Upon City Council's recommendation of approval, the applicant will forward the application to the Arizona Department of Liquor Licenses and Control for final processing.
